

### **WESBANK TRANSPORT DONATION/SPONSORSHIP POLICY**

Wesbank Division of FP Du Toit Transport believes in giving back to the community and takes great pride in supporting local organizations and previously disadvantaged groups (racially disadvantaged person's, women and persons with disabilities) whenever possible. We donate in a variety of ways; volunteering time, rendering of services and through financial support. The purpose of our efforts is to support our corporate objectives, impact/strengthen the wellbeing of our community and represent our corporate values publicly.

#### **Areas of support:**

- Education support for the underprivileged/ previously disadvantaged groups.
- Support of sport developmental programs for previously disadvantaged groups.
- AIDS orphans homes.
- Shelters for abused/vulnerable children and women
- Child welfare organizations.
- Feeding schemes/soup kitchens for the underprivileged.
- Homes for the Aged.
- Informal organizations which support previously disadvantaged communities in terms of shelter, medical assistance, education, training and development.
- Organizations involved in fundraising campaigns with regards to the treatment/prevention of life threatening diseases e.g. cancer, diabetes, etc.

#### **We do not consider requests from:**

- Political organizations. We respect freedom of political beliefs, but as a company, choose not to donate to any specific political group.
- Organizations that discriminate on the basis of race, color, creed, or gender.
- Requests from religious organizations will not be considered; however, a community program sponsored by a religious organization will be considered (e.g. feeding schemes, foster homes, etc.).
- Organizations which receive a majority of their funding from the Government.
- Programs in communities where Wesbank Division of FP Du Toit Transport does not have a presence.
- Individuals or organizations for profit.

#### **GENERAL RULES AND APPLICATION PROCEDURE**

- The organization or event must be located within the areas of operation of Wesbank Transport
- A qualified applicant is limited to ONE donation within a 12 month period.
- Wesbank Division of FP Du Toit Transport reserves the right to accept or deny any donation or sponsorship and to request detailed information from organizations, requesting sponsorships/donations.
- All charitable donation and sponsorship requests must be in writing and no telephonic requests will be considered.
